## President Tony

Corvette Racing!

This June in France will represent 100 years of racing at the 8.5 mile Le Mans track.

Corvettes have raced since 1960 when John Fitch and Bob Grossman brought their #3 Corvette home in 8<sup>th</sup> place overall and a class win.

Corvettes entered Le Mans in 1967. Bob Bondurant and Dick Gulstrand led it's class until the engine expired at the 12 hour mark.

In 1973 John Greenwood built a wide body Corvette race car. It was extremely fast from the start. In 1974, at the Bama 200 at Talladega, GA., Greenwood broke the track record and won the race. At the IMSA race at Daytona, Greenwood earned the pole and won the race finishing a lap ahead of the 2<sup>nd</sup> place Porsche. Greenwood Corvettes would later achieve speeds in excess of 230 miles per hour at Le Mans and Daytona.

In 1988, Chevrolet built 56 1988 Corvettes specifically for the Corvette Challenge Series. These purpose built Corvettes would race for 2 seasons with great success.

The C5 was completely redesigned and radically improved performance in every measure. In 2001 drivers Ron Fellows, Johnny O'Connell and Scott Pruett finished 1<sup>st</sup> in Class and the 2<sup>nd</sup> Corvette was right behind them at Le Mans.

At Le Mans in 2002, Corvette racing overcame fierce competition from Ferrari, Viper and Saleen to earn its 2<sup>nd</sup> one-two finish.

The C6 in 2005 kept the racing success going, finishing 1<sup>st</sup> and 2<sup>nd</sup> at Le Mans. The Team would go on again to win Le Mans again in 2006, 2009 and 2011. It had won 51 of the 88 ALMS races contested, sweeping the championship in 6 Of 9 years.

Over its 6-year run, 2014-2019, the racing version of Chevrolet's 7<sup>th</sup> generation (C7) would record 17 victories in 73 events, including Le Mans in 2015, Daytona in 2015 and 2016, and Sebring in 2015, 2016 and 2017.

Since introduction of the C8 in 2020, Corvette has struggled with winning, however winning the 1<sup>st</sup> race at Lime Rock on July 4, 2020. This was Corvette racing 100<sup>th</sup> win since 2000.

In 2021, Corvette racing did win the Championship with Nicky Catsburg, Jordan Taylor, Antonio Garcia, Tommy Milner, Nick Tandy and Alexander Sims.

The new C8R Z06 should bring more success in 2023-2024.

Thanks to the 12 Club members who drove to Duarte and enjoyed the Justice Brothers offices and awesome car collection. The tour by Ed Justice, Jr. was special and lunch at the Old Spaghetti Factory was great.

Remember we are planning another run to the Lions Automobilia Foundation in Rancho Dominguez on April 8<sup>th</sup>. So plan this Saturday on a fun run and having lunch afterwards.

## NCCC PRESIDENT'S MESSAGE: March 2023

Here we are at March 1<sup>st</sup> and gearing up for convention in Bowling Green!

I have been remiss in sending notice of Patrick Dolan passing on February 6<sup>th</sup>. Patrick joined Royal Corvettes of Western Michigan in 1968, he served nationally as VP of Competition, President and Director of Charity. Patrick's dedication to NCCC and involvement through the years - not only in the areas he chaired but by working on the sponsorship program and attending other events to promote our program- will be missed. As a tribute to Patrick, a Corvette cookbook was given away for a door prize at the February meeting. Those that were around for the Charity raffles at convention can relate to that.

Patrick was inducted into the National Corvette Museum Hall of Fame in 1998 for being a Founding Member of the NCM as well as his continuing involvement in its the initial success. There is a news release from the NCM on 2/13.

Going forward, I plan to use this email to ensure all members are aware of the **proposed changes to go into effect with the 2024 Rulebook**. Each governor/club gets to vote on these changes. Don't forget that all this information and more detail is also on our website at [www.corvettesnccc.org](http://www.corvettesnccc.org).

### From the National meeting held in St. Louis, Feb. 25<sup>th</sup>:

#### *Standing Rule change for the Competition Rulebook:*

The CURRENT procedure calls for the rulebook to be presented and voted on as a whole. The vote is taken at the national meeting.

The PROPOSED procedure calls for the changes (an item may affect several areas of the rulebook but will be grouped as one change) to be voted on separately. Each governor can vote yes or no one each change. The vote will be by electronic ballot.

What will be voted on at the May 6<sup>th</sup> meeting will be which procedure will be used.

#### *Other competition updates:*

For C8 Z06s class "PP" was added to the database for speed events.

The People's Choice Concours event title has been changed to Car Show. The previous title was confusing since there is no formal judging at a car show.

At a Concours, C8s will not have their engine judged. For Best of Show judging, no engines will be judged.

#### *Changes for the next rulebook:*

Add Friday after Thanksgiving, as well as the Friday after 4<sup>th</sup> of July (if on a Thursday. You may have a 3-day weekend, but not four days) to hold sanctioned events.

Change the number of sanctions awarded to each club to 14 – 7 events per day that will allow a full weekend.

Time Trials can have 3 sanctions per session to accommodate 7 events per day.

Change the National Champion awards to Top competitors to Speed type events (high/low speed, time trials, and drag events) and Non-Speed type events (concours, car shows, rallies and funkana events) to acknowledge all types of competitors.

We have been advised by our insurance broker that "Non-NCCC members are not covered by NCCC insurance" must be on every flyer for all types of events.

Wow, this is getting long. Next month, I won't have to play catch up so the message will be shorter on updates.

Convention in Bowling Green is booming! So far there are 680 entrants! The overflow Hotels have been generous is providing rooms at a convention rate but that goes away May 21<sup>st</sup>. Many of the events are full, but you can still get on a waiting list or sign up for a tour. Don't forget to stick around for the 70<sup>th</sup> anniversary of Corvette Gala at the National Corvette Museum on Friday!
